have Granted, Sold and Conveyed, and by these presents do Grant, Sell and Convey, unto the said Trustees of General Association of Davidian Seventh-Day Adventists, an Association constituting a Church,

of the County of McLennan State of Texas all that certain piece or parcel of land situate, lying and being in the County of McLennan, State of Texas, and described as follows: Being 941.69 acres of land, more or less, parts of Sections 3, 4 and 5 in Range 4 of the subdivision of the Thomas de la Vega 11 League Grant on the east side of the Brazos River;

BEGINNING - at a point where the west line of said sections intersect the middle of Waco and Springfield Road;

THENCE - N. 28 W. with the west line of said Sections, 2561-1/2 varas to W. H. Davis S. W. corner;

THENCE - N. 62 E. passing Davis S. E. corner at 300 varas, and at 704' varas Herndon's S. E. corner in middle of road for all corner of this;

THENCE - N. 28 W. with Herndon's E. or N. E. line and Mrs. Yowell's E. or N. E. line 1035 varas to corner in center of Williams Creek under the bridge;
